**Dear Mr. Yumer,**

The company ICGB AD has received the following projects for coordination with the Contracting Authority – Dzhebel Municipality, namely:

- Object: “Relocation of the water mains for Sofiytsi Village, Dzhebel Municipality outside the easement of the route of the Greece – Bulgaria gas pipeline and intersection of the water mains with the pipeline and its optical cable in the land of Balabanovo Village, Momchilgrad Municipality”. The development is on parts “WS&S, BoQ”.
- Object: “Water Supply of the Sofiytsi Village, Dzhebel Municipality from Balabanovo Pumping Station. The development is in part “Geodetic recording of the territory between the easement of the pipeline and the relocation of the water mains outside the pipeline range”

After reviewing and comparing with the IGB gas pipeline project, ICGB AD agrees with the above-described project developments, subject to the following requirements:

1. With respect to the intersection of the gas pipeline and the fibre-optic cable routes located at 0.75m and 7m from the pipeline axis in east direction, a minimum clearance of 0.63m between the design water mains and the transfer gas pipeline shall be observed.
2. The notification for the forthcoming implementation of the construction and installation works should be in writing and not less than 5 days prior to their commencement.
3. For the completed construction, an executive documentation on the range of the intersection shall be presented to ICGB AD, showing clearly the water pipeline displacement levels.

At the water pipeline installing, after the IGB gas pipeline execution, the following additional requirements shall be met:

1. Provision for actions and materials to strengthen the facilities owned by ICGB AD during the construction and installation works in the intersection area.
2. All excavation works in the easement of the gas pipeline should be carried out manually, with great care, in the presence of representatives of ICGB AD or a person authorized thereby.

3. In the event of damage to the facilities owned by ICGB AD during the construction and installation works, the investor shall recover the property at its own expense.
4. The natural terrain shall be restored with a backfill, packed in layers, following the construction and excavation activities in the easement of the ICGB AD facility.
