#### General conditions:

1. In the public procurement may participate all interested Bulgarian or foreign natural and/or legal persons or their alliances (consortiums), as well as any other formation, which meets the requirements, specified in the Public procurement act of the Republic of Bulgaria and the conditions in the present announcement (notice) and the documentation for participation, announced in advance by the Contracting authority

A person, which participates in consortium or has given consent and appears as a subcontractor in

the offer of another participant, may not submit an individual offer.

One natural or legal person may participate only in one consortium.

4. Related parties by virtue of §2, p. 45 of the additional provisions of PPA may not submit individual offers. If during the time of conduction of the procurement arises such circumstance, the Participant shall be obliged to notify in written the Contracting authority in 3-day term following its occurrence.

5. Branch of a foreign entity may be an individual participant, if it can independently submit an offer and execute contracts according to the legislation of the state, in which it is established. If for proving compliance with the requirements for economic and financial standing, the technical and professional capacities, the branch refers to the resources of the trader, the branch has to furnish proofs, that in the course of implementation of the procurement it shall have on its availability these resources.

Participants - Consortiums:

The Contracting authority shall not set out a requirement for establishment of a legal person, when the Participant, selected for contractor, appears consortium of natural and/or legal

- b) If the consortium is registered under BULSTAT before the date of submission of the offer for the present public procurement, it has to be indicated BULSTAT and/or other identifying information according to the legislation of the state, in which the Participant is established, as well as address, including electronic address, for correspondence. In case it has not been established (registered) upon award of the implementation of the activities, subject of the present public procurement, the Participant must submit a certified copy of certificate for tax registration and registration under BULSTAT or equivalent documents according to the legislation of the state, in which the consortium is established, after it is notified about the made classification and prior to execution of the Contract on award of the present public procurement.

The rights and obligations of the participants in the consortium;

The distribution of the responsibility amongst the members of the consortium;

The type of activities, which shall implement each of the members of the consortium; The document must be signed by the persons in the consortium, as it has to definitely indicate the representative of the consortium. When in the contract is not indicated the person, who represent the participants in the consortium, there has to be submitted a document, signed by the persons in the consortium, in which is indicated the representative.

In the document for establishment of consortium must be certified in an unconditional way that the participants in the consortium shall undertake joint responsibility for the participation in the public procurement and for the period of implementation of the procurement all members of the alliance/consortium shall be obliged to stay in it. The participants in the

alliance/consortium must appoint one person, who shall represent them for the purposes of the procurement.

### 7. Use of subcontractors:

a) If the Participant intends to use subcontractors, it has to specify in the offer the subcontractors and the share of the procurement, which it shall award to them. In such case they have to present proof about the obligations, undertaken by the subcontractors.

b) The subcontractors should meet the respective selection criteria, depending on the type and share of the procurement which shall implement and about them should not exist grounds for exclusion from the procurement, specified in requirements for the personal situation in the present announcement.

c) Regardless of the opportunity for use of subcontractors, the responsibility for implementation of the contract for a public procurement shall lie with the contractor.

d) After execution of the contract and before start of its implementation to the latest, the contractor shall notify the Contracting authority about the name, contact data and representatives of the subcontractors, indicated in the offer. The contractor must notify the Contracting authority for any changes in the provided information in the course of implementation of the procurement.

e) When there is need, by exception shall be admitted replacement or inclusion of a subcontractor during implementation of a contract for a public procurement if the following conditions are cumulatively met:

About the new subcontractor do not exist the grounds for exclusion, specified in requirements for the personal situation in the present announcement;

The new subcontractor meets the selection criteria, which have been met by the former subcontractor, including as regards the type and share of the activities, which shall implement, corrected depending on the activities, implemented so far.

Note: upon replacement or inclusion of a subcontractor, the contractor shall submit to the Contracting authority all documents that prove the compliance with these conditions.

## 8. Use of third parties capacity

a) The participants may refer for the present public procurement to capacity of third parties, regardless of the legal relation between them, as regards the criteria connected with the economic and financial standing, technical capacities and professional competence.

b) As regards the criteria related to professional competence, the participants may refer to the third parties capacity only if the persons, by whose education and qualification or experience shall be proven correspondence to the requirements of the Contracting authority, participate in the implementation of the part of the procurement, for which this capacity is needed.

c) When the Participant shall refer to third parties capacity, it should be able to prove that it shall have their resources available by submitting a document about the obligations, committed by the third parties.

d) The third parties should meet the respective selection criteria, for proving of which the Participant refers to their capacity and for these third parties should not exist grounds for exclusion from the public procurement specified in requirements for the personal situation in the present announcement.

When a participant in the procurement is consortium of natural and/or legal persons, it may prove the correspondence with the selection criteria by the capacity of third parties, in observing the conditions under b. "b" and b. "d".

## Requirements for personal situation:

### Grounds for exclusion:

1. The Contracting authority shall exclude from participation in the public procurement a participant, about which exist the grounds under art. 54, para 1 of PPA, as follows:

(1) When the Participant is convicted by effective verdict for a crime under art. 108a, art. 159a – 159d, art. 192a, art. 194-217, art. 219 – 252, art. 253 – 260, art. 301 – 307, art. 321, 321a and art. 352 – 353f of the Criminal code;

(2) When the Participant is convicted by effective verdict for a crime, analogical to those of the precedent paragraph, in another Member-state or in a third state;

(3) When the Participant has liabilities for taxes and social security contributions by virtue of art. 162, para 2, p.1 of the Tax-insurance procedure code and the interests to them, to the state or to the

municipality under the seat of the Contracting authority and of the participant, or analogical liabilities according to the legislation of the state, in which the Participant is established, proved by effective act of a competent body.

(4) When there is inequality in the cases under art. 44, para 5 of PPA;

(5) When it is established that:

a) the Participant has submitted a document with untrue contents, related to certification of the non-existence of grounds for exclusion or the correspondence with the selection criteria;

b) the Participant has not submitted required information, related to certification of the non-

existence of grounds for exclusion or the correspondence with the selection criteria.

- (6) When about the participant is established by effective penal ruling or judgment, an infringement of art. 61, para 1, art. 62, para 1 or 3, art. 63, para 1 or 2, art. 118, art. 128, art. 228, para 3, art. 245 and art. 301 305 of the Labor code or art. 13, para 1 of the Labor migration and labor mobility act or analogical liabilities, established by an act of a competent body, according to the legislation of the state, where the candidate or the participant is established.
- (7) When there is a conflict of interests, which cannot be eliminated.

The grounds for exclusion shall apply until expiration of the terms under art. 57, para 3 of PPA. If during the time of the procedure occurs some of the grounds for exclusion under art. 54, para 1 or art. 101, para 11 of PPA, the Participant shall be obliged to notify the Contracting authority in three-day term following its occurrence.

- 2. It shall be excluded a participant, about which exist any of the circumstances under art. 3, p. 8 Act on the economic and financial relations with companies, registered in preferential tax regime jurisdictions, the persons related to them and their beneficial owners—it is registered in jurisdictions with preferential tax regime including by civil partnership/consortium, in which participates a company, registered in a jurisdiction with a preferential tax regime, except in case of existence of the exceptions by virtue of art. 4 of the above-mentioned act.
- 3. It shall be excluded a participant, about which exist circumstances under art. 69 of the Anti-corruption and forfeiture of unlawfully acquired assets act.

4. Measures for proving reliability:

If for a participant exist some of the specified grounds for exclusion under art. 54, para 1 of PPA, the Participant shall have the right to submit in accordance with art. 56 of PPA proofs, that it has undertaken measures to guarantee its realiability despite the existence of the respective reason for exclusion.

When the Participant has undertaken measures for reliability before submitting the offer for participation in the present public procurement, the measures have to be described in the enclosed form of declaration under art. 192, para 3 of PPA

As proofs for the reliability of the participant should be submitted the documents under art. 45, para 2 of the Implementing rules of PPA.

#### Certification:

The participants shall declare the non-existence of the above-stated Grounds for exclusion also by filling in part "A" and part "B" of the form of declaration enclosed to the announcement, according to art. 192, para 3 of PPA (Annex № 1).

Clarification: Part "A" has to be signed by the person, who can independently represent the participant. Part "B" has to be signed by all persons, who represent the participant. When a representative of the participant is legal entity, the grounds refer to the natural persons, who represent it according to the register, in which is entered the legal entity, if any, or the documents, certifying its legal personality.

#### Other information:

1. Submission of the offer shall oblige the participants to accept all requirements and conditions, specified in this announcement, in observing PPA and the other normative acts, related to the implementation of the subject of the procurement. Upon making the offer, each participant must strictly observe the conditions, announced by the Contracting authority. Placing conditions and requirements by the participant, different from those of the Contracting authority, shall lead to exclusion of the participant.

2. The offer shall be made in Bulgarian in observing the forms, published in the Buyer's profile of the Contracting authority. Variants of the offer shall not be admitted. If there are variants in the offer, the participant shall be excluded from participation.

- 3. Until expiration of the deadline for submission of the offers each participant may modify, supplement or withdraw its offer.
- 4. Each participant shall have the right to submit only one offer.
- 5. The costs related to drawing and submission of the offer shall be at the expense of the participant. The participants may not raise claims before the Contracting authority in relation to costs for drawing up and submission of an offer regardless of the outcome of the procedure.

#### 6. Contents of the offer:

- 6.1. List of the submitted documents in the offer (filled in, signed and stamped by the participant);
- 6.2. Declaration under art. 192, para 3 of PPA according to the form of Annex № 1 part "A" and part "B";
- 6.3. Copy of documents for proving the undertaken reliability measures, according to art. 45, para 2 of the Implementing rules on PPA in connection with art. 56, para 1 of PPA, when applicable;
- 6.4. In cases of participants consortiums a copy of a document from which to be seen the legal grounds for establishment of the consortium.
- 6.5. Declaration under art. 102 of PPA filled in, signed and stamped by the participant according to the form of Annex № 2.
- 6.6. Proposal for execution of the procurement under the respective separate position (according to the sample of Appendix № 3.1. Or 3.2.) - in accordance with the technical specification and the requirements of the contracting authority - original, together with the appendices to it;

7. The participants must submit an offer until the deadline, indicated in the announcement. Each offer has to be submitted in a sealed, intact, non-transparent envelope by the participant or by a representative, authorized by it, personally or by post by registered letter with acknowledgment of receipt, or by courier service, addressed to "ICGB" AD to the above-mentioned address. On the envelope has to be indicated: the name of the participant, including the participants in the consortium (when applicable); correspondence address, phone and if possible - fax and electronic address; the title of the procurement. Each participant has the right to submit an offer for one or all lots. In case the participant submits an offer for both separate positions, the participant should submit separate Technical and price proposals. 8. Clarifications on the documentation - upon written request made up to three days before expiration of the deadline for receiving offers, the Contracting authority, on the next working day to the latest, shall publish in the "Buyer's profile" on internet address: http://www.icgb.bg/profil-na-kupuvacha/obiavi-ipokani, a written clarification on the conditions of the public procurement. By the public provision (of the clarification) it shall be deemed that all interested participants are notified. When the Minutes of meeting from the work of the committee are not received by the participant in any of the ways, specified in art. 43, para 2 of PPA, the Contracting authority shall publish a communication to it in the Buyer's profile, in the electronic case of the announcement. The Minutes of meeting shall be deemed served as of the date of publication.

## 9. Other grounds for exclusion:

It shall be excluded from participation in the public procurement:

1. A participant, which does not meet the established conditions for economic and financial standing and technical and professional capacities (selection criteria) or which does not implement or has not implemented another condition, specified in the present documentation/announcement;

2. A participant, which has submitted an offer non-corresponding to:

a) the preliminarily announced conditions for implementation of the procurement;

- b) rules and requirements, related to environment protection, social and labor law, applicable collective agreements and/or provisions of the international ecological, social and labor law, which are listed in Appendix No 10 of PPA;
- 3. a participant who has not filled in all unit prices in the price offer. All unit prices should be final without incl. VAT.
- 4. a participant, which has not submitted in due time the justification under art. 72, para 1 of PPA (when a proposal, connected with price or costs due to evaluation, is 20% more favorable than the average value of the proposals of the other participants under the same indicator for evaluation) or which offer is not accepted pursuant to art. 72, para 3-5 of PPA;

5. participants, which are related parties;

- 6. a participant, which has submitted an offer, non-corresponding to the conditions for submission including those about form, way and term;
- 7. a participant, which after a request or invitation by the Contracting authority does not extend or confirm the term of validity of its offer.
- 8. The offers have to be drawn up in observing the obligations, related to taxes and social security contributions, environment protection and protection of employment and labor conditions. Non-observance of the above-stated requirement shall lead to exclusion.
